# Minutes of the First General Session Tuesday, August 15, 2023

#### 1. Call to Order

President Margie Holcomb (VA) called to order the fiftieth (50<sup>th</sup>) meeting of the EANGUS Auxiliary at 9:00 a.m. in Suite 112/113 in the Mayo Civic Center, Rochester, Minnesota.

#### 2. Invocation

Chaplain Shelia Brookins (KY) offered the invocation.

# 3. Pledge of Allegiance

Vice President Pam Adams (AL) led members in the Pledge of Allegiance to the Flag of the United States of America.

#### 4. Opening Remarks and Introductions

President Margie Holcomb (VA) welcomed attendees and introduced the Past Presidents who were in attendance: Sara Hendricks (IA/NM); Dorothy Inglese (CA); Sheila Bandy (KY); Debra Campbell (OK); Vivian Taylor (MS); Jenny Lainhart (KY); Judy Wood (AL); Connie Myers (MS); and Angela Kennebeck (IA). President Holcomb (VA) recognized the Executive Council (EC): Pam Adams (AL), Vice President; Vivian Taylor (MS), Secretary; Debra Campbell (OK), Treasurer; and Angela Kennebeck (IA), Immediate Past President; Area II Directors Cathy Hammack (WV) and Gretchen Gipe (KY); Area III Directors Stella Cameron (SC) and Pam Brown (TN); Area IV Directors Judith Putman (KS) and Andrea Holt (KS); Area V Directors Edna Steinberg (SD) and Catherine "Cathy" Berry (WI/MN); Area VI Directors Richard Bryant (NM) and Linda Lyon (WY); and Parliamentarian Rhonda Gorrell (NM). President Holcomb (VA) invited the First Timers to stand to be recognized. Seven (7) First Timers attended the First Timers meeting on August 13, 2023. [Heidi Harper-Riley and Jessica Noel, Idaho; Renea Nein, Kentucky; Pam Woodruff and Sheryl Morse, Michigan; Gloria Gutierrez, New Mexico; and Angie Stroh, Utah.] President Holcomb (VA) noted that Arizona and Idaho Auxiliaries had become active again.

# 5. Adoption of Agenda

Thomas McKennie (GA) moved that the agenda, as printed in the Conference Book on pages 4-6, be adopted as printed. Past President Connie Myers (MS) seconded the motion. Motion carried.

# 6. Report from Credentials and Rules Committee

Pam Adams (AL), Vice President and Chair of the Credentials and Rules Committee, gave the report from the Committee. Credentialing of delegates was performed on August 15, 2023, in the corridor outside Suite 112. Delegates from sixteen states, to include At Large, were credentialed. Jenny Lainhart (KY) moved the report on delegates and proxies be accepted as reported; Michele Johnson (PA) seconded motion. Motion carried. After the vote to approve the report of twenty-eight (28) delegates and twenty-seven (27) proxies, Arkansas entered the chamber which brought the total delegates to twenty-nine (29). Minnesota was found to have been inadvertently reported as zero (0) rather than one (1). That addition changed the total number of delegates from twenty-nine (29) to thirty (30). All EC members were present with five (5) Officers, ten (10) Area Directors, and the Parliamentarian.

# 7. Adoption of Standing Rules

Past President Connie Myers (MS) moved for the adoption of the standing rules as printed on page 8 in the Conference Book. Marlys List (SD) seconded the motion. Motion carried.

# 8. Roll Call of Committee Chairs and Appointees

Secretary Vivian Taylor (MS) called the roll of Committee Chairs and Appointees printed on page 29 in the Conference Book which indicated all Committee Chairs and Appointees were present except for Finance Chair Mary Gallegos and Legislative Chair Trayce Young, both of whom were excused. Past President Dorothy Inglese (CA) was added to the list as Sergeant at Arms.

#### 9. Minutes from the 2022 General Sessions

The minutes from August 09, 2022, and August 10, 2022, had been linked to *The Signal* in the September 2022, June 2023, and July 2023 editions of *The Signal* and were published in the 2023 Conference Book on pages 9 through 28. The minutes published were not the final draft. The following corrections were noted by Secretary Taylor (MS): page 8, number 8, last bullet, delete; correct spelling of McKennie, pages 10, numbers 9 and 11, and page 26, number 17; change 0 to (, page 26, number14; and page 26, number 15, delete Gretchen Gipe (KY) and replace with Linda Lyon (WY). Amanda Wilwert Bradley (KS) moved the minutes be approved as published with stated corrections; Past President Connie Myers (MS) seconded the motion. Motion carried.

#### 10. Guests

**Lowery Guynes**, National Guard and Reserves Representative from Humana was introduced, and President Holcomb (VA) expressed gratitude to Humana for sponsoring the printing of the Conference Book.

**Kevin Hollinger**, Legislative Director, EANGUS, stated that he was grateful for the sacrifices made by military members, employers, and spouses.

# 11. Treasurer's Report

Treasurer Debra Campbell (OK) reported the Finance Committee met on August 12, 2023, in Heritage 1, Kahler Grand Hotel and on August 13 in Suite 112/113 of the Mayo Civic Center. Committee members present were Stella Cameron (SC), Area III; Andrea Holt (KS), Area IV; and Cathy Berry (WI/MN), Area V. Treasurer Campbell was an ex officio member of the Committee. Guests present at the Committee meetings were Past President Dorothy Inglese (CA), Area VII; Immediate Past President Angela Kennebeck (IA), Area V; Secretary and Past President Vivian Taylor (MS), Area IV; and Steve Burris, Immediate Past Treasurer of EANGUS. Finance Committee members Stella Cameron (SC), Area III and Cathy Berry (WI/MN), Area V conducted the annual review of the financial records. They found bank statements, deposits, check register, credit card transactions, and receipts to be in order. The 2023 budget approved by the delegates at the 2022 EANGUS Auxiliary Conference was in the Conference Book on pages sixteen (16) through seventeen (17). The Finance Committee, with advice from Steve Burris, Immediate Past Treasurer of EANGUS, began the process to achieve a balanced budget. Steve also suggested ways the Auxiliary might consider making future investments. The 2024 proposed budget showed a projected income of fifteen thousand nine hundred dollars (\$15,900.00) and projected expenses of twenty-one thousand four hundred seventy-five dollars (\$21,475.00), which would leave five thousand five hundred seventy-five dollars (\$5,575.00) to balance the budget. The Finance Committee presented the proposed budget for 2024 to the EC on August 14, 2023; the EC voted to recommend the budget to the membership.

#### 12. Committee Reports

The following Committee reports were in the Conference Book on pages 30 through 52: Finance, 2023 Budget; Family Affairs (it should be noted that member Marlys List is from South Dakota not North Dakota); Finance, report for 2022; History; Legislative; Lifetime Membership; Membership; Resolutions; and Scholarship. Reports, as listed, were for information only.

#### 13. Constitution Committee

On May 15, 2023, Auxiliary member, Amanda Wilwert Bradley (KS) submitted proposed revisions to the Auxiliary Constitution and Standard Operating Procedures to Auxiliary President Margie Holcomb (VA) and Constitution Committee Chair Richard Bryant (NM). President Holcomb (VA) distributed the proposed changes to the Area Directors and the state presidents and published the same in *The Signal* on July 19, 2023. The Constitution Committee Co-Chair had summarized the proposed revisions into three broad categories: (1) revisions addressing the inconsistencies between the Constitution and the Standard Operating Procedures; (2) revisions changing the deadline for dues and delegates; and (3) revisions expanding the category of individuals eligible to be annual members of the Auxiliary.

At the invitation of Auxiliary President Margie Holcomb (VA), Amanda Wilwert Bradley (KS) presented the proposed changes to the Executive Council (EC) during the EC meeting on August 14, 2023. The EC voted to present the following proposed revisions (outlined below) to the membership:

- Article III, Individual Membership, Section 3.3. Dues.
- Article IX, Conferences, Section 9.4(c) Delegates, Alternates or Proxies.

The Executive Council voted to delay presenting all other proposed revisions to the Constitution so that the Constitution Committee and Membership Committee could consider the revisions addressing the expansion of the Auxiliary membership.

The Constitution Committee met in Suite 112/113 of the Mayo Civic Center at 11:00 a.m. on August 14, 2023. Those present at the Constitution Committee meeting were Committee members: Richard Bryant (NM), Co-Chair; Amanda Wilwert Bradley (KS) Co-Chair; Past President Jenny L. Lainhart (KY); Melody Stroka (MS); Area II Director Cathy Hammack (WV); Past President Judy Wood (AL); Immediate Past President Angela Kennebeck (IA) and additional attendees Past President Connie Myers (MS), Past President Sheila Bandy (KY), Past President and Treasurer Debra Campbell (OK).

The Constitution Committee reviewed the proposed revisions to the Auxiliary Constitution submitted by Amanda Wilwert Bradley (KS) to Auxiliary President Holcomb (VA) and Committee Chair Bryant (NM) on May 15, 2023. The Constitution Committee also considered the votes of the Executive Council on the proposed revisions.

The Constitution Committee agreed with the EC on recommending to the Auxiliary delegates the revisions concerning the revisions to Article III, Individual Membership, Section 3.3. Dues and Article IX, Conferences, Section 9.4(c) Delegates, Alternates or Proxies.

The Constitution Committee also agreed with the EC on the proposed revisions to the Auxiliary membership qualifications. The Constitution Committee agreed that a joint Constitution and Membership committee should consider the expansion of membership; the joint committee would present proposed revisions at the 2024 Convention.

The Constitution Committee disagreed with the Executive Council's decision to delay presenting to the Auxiliary the below proposed revisions. The Constitution Committee believed those proposed revisions were necessary revisions addressing provisions overlooked by the Constitution Committee in an earlier draft of the Constitution. The Constitution Committee recommended in favor of presenting the following proposed revisions to the Auxiliary for a vote:

- Article V, Officers, Section 5.2(d) Treasurer
- Article VI, Area Directors, Section 6.1 Duties
- Article VII, Committees, Section 8.2(i) Membership Committee

The Executive Council and Constitution Committee recommended adoption of the following Constitution revisions.

- Article III, Individual Membership, Section 3.3. Dues.
  - Ourrent provision: "Annual prescribed dues as set forth by the AUXILIARY are to be paid to the AUXILIARY Treasurer by the treasurers of the chartered states, accompanied by a complete name and address for each member whose dues are being paid, postmarked by **December 31** of each year."
  - Revised provision: "Annual prescribed dues as set forth by the AUXILIARY are to be paid to the AUXILIARY Treasurer by the treasurers of the chartered states, accompanied by a complete name and address for each member whose dues are being paid, postmarked by April 30 of each year." Amanda Wilwert Bradley (KS) moved to approve the revision in Article III, Individual Membership, Section 3.3. Dues. Past President Sheila Bandy (KY) seconded motion. Motion carried.
- Article IX, Conferences, Section 9.4(c) Delegates, Alternates or Proxies.
  - Current provision: "Must be members in good standing as of December 31 of the year preceding the Conference affected."
  - Revised provision: "Must be members in good standing as of April 30 of the year of the Conference affected." Amanda Wilwert Bradley (KS) moved to approve the revision in Article IX, Conferences, Section 9.4(c) Delegates, Alternates or Proxies. Past President Jenny Lainhart (KY) seconded motion. Motion carried.

The Constitution Committee recommended adoption of the following Constitution revisions.

- Article V, Officers, Section 5.2(d) Treasurer
  - o Current provision: "Be required to have the approval of the Executive Council for expenditures of funds in excess of five hundred dollars (\$500.00)."
  - o Revised provision: "(7) Be required to have the approval of the Executive Council for expenditures of funds in excess of five hundred dollars (\$500.00)." Amanda Wilwert Bradley (KS) moved to approve the revision on 5.2 (d) Treasurer. Area V Director Cathy Berry (WI/MN) seconded motion. Motion carried.
- Article VI. Area Directors, Section 6.1 Duties
  - O Current provision: absent
  - O Revised provision: "(e) Perform such other duties as are usually performed by Area Directors, or as may be prescribed by this Constitution or assigned by the President of the AUXILIARY." Amanda Wilwert Bradley (KS) moved to approve the revision of Article VI, Area Directors, Section 6.1, Duties. Immediate Past President Angela Kennebeck (IA) seconded motion. Motion carried.
- Article VII, Committees, Section 8.2(i) Membership Committee
  - O Current provision: absent
  - Revised provisions:
    - "(3) Render a report to the Auxiliary at the annual General Conference and otherwise as requested by the President."
    - "(4) Perform such other duties as are usually performed by membership committees, or as may be prescribed by this Constitution or as assigned by the President of the AUXILIARY." Amanda Wilwert Bradley (KS) moved to approve the revision in Article VII, Committees,

Section 8.2(i) Membership Committee. Area VI Director Richard Bryant (NM) seconded the motion. Motion carried.

### 14. Philanthropic Update

Chair Thomas McKennie (GA) reported that the Philanthropic Committee met on August 13, 2023, at the Mayo Civic Center. Chair McKennie (GA), Co-Chair Suzanne Emerson (VA), and Janice Barnette (VA) were present at the meeting at which Janice suggested the Committee contact the Ronald McDonald House in Rochester to determine whether someone would be present to accept a donation. The Committee made contact and learned a representative would be present on August 16, 2023. The Committee encouraged members and states to donate to the 2023 philanthropic project. The Chair would present the donation on August 16, 2023.

#### 15. Nominations Report

Chair Judy Wood (AL) provided a printed report which indicated that Areas had elected the following Area Directors to serve:

Area VI—Linda Lyon (WY), 2 years; Richard Bryant (NM), 1 year

Area VII—Dorothy Inglese (CA), 2 years; Area elected only one Area Director.

Area I did not elect an Area Director.

Areas elected the Area Directors listed in **bold** to serve for two years and the other directors would serve the second year of her/his term.

The Nominations Committee Report was filed for the record.

■ Date of the 2024 Conference—August 18-21, 2024

- Location for 2024 Conference—Detroit, Michigan. Jeff noted that Detroit had invested millions of dollars to assist in providing an outstanding Conference location.
- There would be no registration fee, as such. The Michigan Conference required one hundred dollars (\$100.00) per person to register to determine the number of attendees. - Frisby noted that Eastern Market provides a unique Detroit, Michigan flavor.
