## History

The EANGUS Auxiliary was formed in 1973 during the second EANGUS Conference in Des Moines, IA when 44 ladies from 16 states met to discuss the possibility of forming a national Auxiliary to support EANGUS. The Auxiliary constitution and by-laws were created and approved in Oct. 1974. In 1975 13 states were presented with the first charter certificates. Those states were Arkansas, Arizona, Colorado, Kentucky, Louisiana, Maryland, Mississippi, Missouri, Montana, Nebraska, South Dakota, Washington and Ohio. Through the years 50 states and territories have been chartered. At the 8th annual EANGUS Auxiliary conference, the motto, "Side by Side, We Stand with Pride" was adopted. The Auxiliary has met every year at the EANGUS conference except 2020 due to Covid.

## PURPOSE OF THE AUXILIARY

The commitment of the EANGUS Auxiliary is to support **The Enlisted Association of the National Guard of the United States (EANGUS)**, in attaining legislative goals and objectives and to provide support and fellowship among National Guard families. Along with supporting the EANGUS legislative efforts, the Auxiliary is also concerned with family issues and provides scholarships to benefit members, members spouses and members children and grandchildren.

## WHAT DOES THE AUXILIARY DO FOR FAMILIES

The Auxiliary has supported EANGUS in its legislative efforts. Listed below is a small number of Legislative accomplishments achieved on behalf of Guard members and their families.

1988 – Secured ID cards for NG dependents.

1994 – VA Burial Bill expanding burial benefits to NG members.

2000 – TRICARE for Life for Medicare eligible retirees & families passed. TRICARE Senior Pharmacy program started.

2003 – Made VA home loans permanent. Authorized unlimited commissary access.

2008 – Allow transfer of GI Bill to spouse/ children with service commitment.

2015 - Secured language to promote unique role of NG in cyber capabilities & Federal/state authorities.

2020 - Expanded VA Home Loan eligibility for Title 32 service.

2020 – Expanded eligibility for counseling & outpatient mental health services. Regardless of deployment status.



## AVAILABLE MEMBERSHIPS

**ANNUAL MEMBER:** A spouse of an active, retired or former Guard member who is a member of EANGUS. The spouse must be a member of a state Auxiliary chartered to the national Auxiliary.

**LIFE MEMBER:** A current annual member may apply for life membership by paying a one-time dues payment that is determined by current state and national dues that apply up to age 60. The applicant's spouse must be a life member of their state association and EANGUS.

**ASSOCIATE MEMBER:** An individual who supports the objectives of the Auxiliary but does not otherwise qualify for annual or lifetime membership..

**NATIONAL LIFE ASSOCIATE MEMBER:** An individual who supports the objectives of the Auxiliary but does not otherwise qualify for annual or lifetime membership. This membership is a one-time payment of \$100.00
